Warning by Vietnam Trade Office in Nigeria:

*There were some scam occurred in the communication between businessmen of Vietnam and Nigeria during last years:*

- 1) The Vietnamese importers deposited the amount of 30% (50%) of the contract value, but the Nigerian exporters did not deliver the shipments, did not refund the deposit amount to the Vietnamese importers (wood timber, garment & textile);*
- 2) The Nigerian exporters delivered goods (wood timber), sent the original documents (including B/L) to Vietnamese importers, but the Vietnamese importers did not pay the contract balance value at 30% (or 50%) to the Nigerian exporters.*
- 3) To avoid risks in exportation and importation, Vietnam Trade Office in Nigeria strongly recommends to both enterprises of Vietnam and Nigeria as follows:*
  - Do not transfer money in advance to your customers, when to be requested. For example, the fee or expenditure of procedure for obtaining an import license (NAFDAC or CITES), brokerage fees, attorney fees, etc.*
  - Apply the irrevocable L/C at sight;*
  - Do not apply the following methods of payment: Telegraphic Transfer (T/T), Document against Acceptance (D/A); Document against Payment (D/P).*
- 4) Vietnam Trade Office in Nigeria will be not responsible, and does not solve any dispute, if the enterprises of Vietnam and Nigeria fail to do the above recommendation.*
