Argentina has received a loan from the International Bank for Reconstruction and Development toward the cost of the Project Development Provincial Public Health Insurance and intends to apply part of the funds from these loans to payments under the Contract " acquisition medical Equipment for New Features " LPI No. PHIP -LPI -3 -B -8.
3. 4. Bidding will be conducted through the international competitive bidding procedures (ICB) procedures specified in the World Bank 's Guidelines: Procurement under IBRD Loans and IDA Credits , and is open to all bidders from eligible source countries as defined in these rules.

6. Qualifications requirements include (a) Average annual income : The amount of average annual sales turnover in the past 3 years must be at least equivalent to 7 times the value of the offer (b) Experience and Technical Capacity i) installed capacity of production: the bidder or the manufacturer, in the event that the bidder is not the manufacturer should have an installed annual average production capacity equivalent to at least the following amounts : Lot 1 : Pumps Infusion syringe 3150 units ; Lot 2: Color Doppler Ultrasound transducers Multipurpose 4 , 441 units , lot 3: Oxygen Mixer (Blender) , 900 units , Lot 4.1 : 1 Fetal Monitor, 333 units ; Lot 4.2: Multiparameter Monitor , 1134 units , lot 5: oxygen saturation meter , 378 units , lot 6:

Respirators highly complex , 720 units ; Lot 7: Fluid Heater , 450 units ; ii) Number of similar contracts executed : The bidder shall be fully implemented at least 3 similar contracts that are the subject of this invitation to tender during the last 2 years . Means similar to the one that has to goods as offered by amounts at least equal to the contract amount offered . iii) Experience: The Bidder must demonstrate that they have manufactured and / or marketed the specific goods offered for a period of not less than 2 years. Specific goods means those goods offered in this tender regardless of make or model .

Bids will be opened in the presence of bidders ' representatives who choose to attend in person at the address at the end of this call , at 12 pm on July 14, 2014 .
