## CONDITIONS OF PARTICIPATION

(to be sent together with the Participation Contact)

### 1. TERMS

The terms and conditions set forth herein are indispensable part of the Participation Contract and shall be valid on all terms. The Exhibitor is obliged to follow and obey the statements herein.

### 2. APPLICATION / CATALOGUE

The deadline for application for the Fair is **AUGUST 9, 2010**. Retail sales are not allowed in the Fair. İZFAŞ is free to accept or reject any applications. Application Forms sent after this deadline shall not be included in the Catalogue. Translation of the special exhibits (except for the main product groups) into Turkish should be sent to İZFAŞ in written; otherwise the translation will be made by İZFAŞ. İZFAŞ does not take any responsibility for technical translation mistakes that should be constituted while translating.

### 3. INSURANCE / SECURITY

İZFAŞ insures the exhibits against fire and does not take any responsibilities for cases of loss, theft, damage or injury to any person. İZFAŞ provides 24-hour general security in indoor and outdoor areas of the fairground. EXHIBITOR may independently insure his/her exhibits against other risks. İZFAŞ is not responsible for force majeure (like civil commotion, strike, lockout, embargo, state of war, disasters etc.)

### 4. PAYMENT

50% advance payment and 50% balance payment for the total allocated area should be delivered to İZFAŞ according to the Payment Plan sent by İZFAŞ to EXHIBITOR. 50% balance payment should be made to İZFAŞ before **AUGUST 9, 2010**. Thus, the total payment for participation should be done before **AUGUST 9, 2010**. EXHIBITOR should pay 10% overdue interest, if EXHIBITOR does not adhere to the terms stated in the Payment Plan. The EXHIBITOR who registers after the deadline for application shall make the total payment at once according to the payment date defined by İZFAŞ.

### 5. CANCELLATION OR REDUCTION ON THE REQUESTED SQM

In case of cancellation, EXHIBITOR has to inform İZFAŞ in written before **AUGUST 9, 2010**. İZFAŞ shall reimburse the advance payment only if EXHIBITOR informed İZFAŞ in written before **AUGUST 9, 2010**. Otherwise, İZFAŞ has to right to keep or demand for the advance payment of 50% even EXHIBITOR has already made the payment or not.

In case of reduction on the requested sqm, EXHIBITOR has to inform İZFAŞ in written before **AUGUST 9, 2010**. Otherwise, İZFAŞ shall charge 50% payment for that deducted part of the allocation area.

In case of cancellation or reduction on the sqm by any applicants who registers after **AUGUST 9, 2010**, the applicant is obliged to make the total payment to İZFAŞ.

### 6. DAMAGE

İZFAŞ provides the EXHIBITOR with the rented stand including the stand space and/or the stand with accessories in good working order. In case of any damage or loss, the EXHIBITOR shall be obliged to cover the damage costs.

### 7. FAIR SETTLEMENT / FAIR DISMANTLING 7 / A GENERAL RULES FOR ALL EXHIBITORS

- İZFAŞ is free to make some allocation changes in the hall plans in which the position of the corresponding EXHIBITOR stays the same.
- It is not allowed to fix the stand construction to any part of the halls. Drilling, screwing, driving nails or using adhesives on the panels, ceiling or the ground is not allowed.
- Loading capacity of the ground is 2.500 kilogram per square meter for indoor areas and overload is not allowed. If the ground is damaged due to case of overload, EXHIBITOR is responsible of covering the damage.
- The maximum height for private stands is 4 meters in Halls 1/A and 1/B, 6 meters in Halls 2,3,4. If the stand is besides the walls near the passageways of Halls 2,3,4; the maximum height is 3 meters.
- It is not allowed to hang any accessories like flags, posters, etc over these height limits.
- All the stands, either in indoor or outdoor areas, can not be transferred or rented entirely or particularly to any other company by the EXHIBITOR without İZFAŞ's written approval. Otherwise, EXHIBITOR accepts to be moved out from the fairground and to pay triple price of the stand as penalty.
- Fair settlement should be completed as of 24:00 on **AUGUST 26, 2010**.
- EXHIBITOR cannot carry the goods out from the stand during the fair period. The move-out will be allowed after 24:00 on **SEPTEMBER 5, 2010**. EXHIBITOR should complete the move-out on the following 3 days after the Fair. İZFAŞ is not responsible for the goods left in the fairground after **SEPTEMBER 7, 2010**.
- EXHIBITOR should have done all financial obligations requested by İZFAŞ and should have made the balance payment in order to receive the permission to leave the fair.

## CONDITIONS OF PARTICIPATION (to be sent together with the Participation Contract)

### 7/B RULES FOR OPTION 1: SPACE ONLY

- EXHIBITOR should send his stand construction plan, which is confirmed by an architect or a civil engineer, to Technical Department of İZFAŞ before **AUGUST 9, 2010**. İZFAŞ shall not allow construction of the stands, which are not confirmed by the Technical Department of İZFAŞ.
- EXHIBITOR should construct his stand fitting to the dimensions according to the Hall Plan sent by İZFAŞ. 3-D drawings and the related plans has to be delivered to İZFAŞ. If the construction of the stand does not fit to the stand dimensions and runs over, Technical Department of İZFAŞ keeps the right to obstruct the construction.
- The request for the electricity power should also be stated in the project (Kilowatt). Design and construction of a private stand should be in accordance with the general view of the fairground. Also the sides of a private stand that are higher than and facing the neighboring stands should be clear and painted in white there shouldn't be any fascia or logo of the company.

### 7/C RULES FOR OPTION 2: SHELL SCHEME

All standard stands, which are constructed by İZFAŞ, will be provided to EXHIBITOR 2 days before the opening of the Fair, including all the accessories and services stated on the Participation Contract.

### 8. ELECTRICITY - WATER -WASTE WATER- PRESSURIZED AIR

- The fairground electricity web has alternate phase of 380 V and 220 V with a period of 50 Hertz.
- **The companies who construct private stands should provide their own electricity board.**
- In case of electricity supply interruption or power failures, İZFAŞ does not undertake any responsibilities.
- EXHIBITOR should contact Technical Department for water request.
- Water and waste water connection is maximum 6 bars. (Available in Halls 2,3,4.)
- Upon request, İZFAŞ shall provide water connection to the stand. The interior connection shall be the company's responsibility.
- Standard pressurized air is provided as maximum 12 bars. For different bar units fewer than 12 bars, the EXHIBITOR should bring his/her own air pressure controller. (Available in Hall 2-3-4)

### 9. TELEPHONE LINE CONNECTION

Telephone line connection fee is 50 USD per connection and is available in all Halls.  
Phone use will be charged after the fair.

### 10. ADVERTISEMENT & PROMOTION ACTIVITIES

- EXHIBITOR, who would like to arrange organizations such as cocktail, show etc. in the fairground, should inform İZFAŞ about the date and place of the activity for approval.
- For seminars and other events, EXHIBITOR could make use of İZFAŞ activity areas upon approved by İZFAŞ.
- EXHIBITOR planning to place advertisement with İZFAŞ's name should ask for İZFAŞ's approval.
- All the advertisements and promotion activities should be made according to the Present Law. In case of any dispute İzmir Courts shall be authorized.
- The sound limit in the Halls is 50 decibel.

### 11. CUSTOM CLEARANCE & STORAGE

EXHIBITOR shall make the custom clearance in the related Customs Directorate according to the valid customs regulations of the Republic of Turkey. For storing services, EXHIBITOR may apply to İZFAŞ.

### 12. ATTENTION

Retail sales are strictly forbidden in the Fair due to the Governmental Law of the Republic of Turkey. İZFAŞ has the right to close to stands, if any sale is being see and approved in the FAIR.
